2007 ROAD PROJECTS

Badger Drive from County D west to the new section, (1 mile) is scheduled to have the road surface ground, 4" of gravel added and 2" of asphalt for a 20' road driving surface. This will complete the length of Badger Dr. Bids are due by April 9. Estimates will be sought for sealcoating the oldest section of Badger Drive - County D to HWY 54 in order to maintain the road's quality. The roadways of Boelter Lake Court and Boelter Lake Lane will be surveyed this spring to determine where the roads should actually be located. It is planned to submit those roads and Crossover Lane for LRIP funding for a 2008 project of grinding and paving.

MAIL BOX LOCATIONS!

Locating mailboxes along the roadside is complicated by many factors. The Postal Service has the requirement that the box bottom be 42- 48 inches above the ground. The support used should easily break off or move out of the way in case of an accident. The box should be located to line up with the far edge of the shoulder - not the edge of the pavement. The Town will be asking those residents with mailboxes that pose a hazard to move them and if necessary the Town will supply shoulder gravel.

DOG LICENSES DUE

April 1 is the deadline for any animal more than 5 months of age on January 1 to obtain a license! The fee is \$6 for neutered or spayed dogs and \$16 if not. The Town Treasurer will issue a license upon proof of vaccination.

Bill Frizzell will have Town Hall office hours of 9 a.m. to 2 p.m. on Saturday, March 31 for those purchasing dog licenses.

A late fee of \$5 shall be assessed for each dog not licensed by April 1. Failure to obtain a license or to not have a dog vaccinated against rabies has a fine of \$150.00

id you know? The Town of Lanark has two out of the fourteen sites listed on the National Register of Historic Places in Portage County. Located on Pipe Road, north of HWY 10 and east of County T, are both sites: the Pipe School and the Severance-Pipe Farmstead. Administered by the



National Park Service, the Register was authorized in 1966 with goals to coordinate and help property owners and groups identify and protect historic sites in the U.S. As of December 2005 the list has 79,000 entries of districts, sites, buildings, structures and objects worthy of preservation. Nominations

containing basic information on the type of significance of the site is sent to the State Historic Preservation Office where it is reviewed by the advisory board and then forwarded to the Keeper of the Register. The nomination is then sent to the National Park Service which approves or denies the nomination. Selection is based on four criteria: 1) Event - made a significant contribution to the broad patterns of history; 2) Person - associated with the lives of persons significant in our past; 3) Design/Construction - distinctive characteristics of a building type, period, method of construction, work of a master, possess high artistic values...; and 4) Information potential - yields information important in history. Both the Pipe School and Farmstead were added to the Register in 1993. The School was built in 1889 with a front gabled style and balloon frame structure. The Farmhouse (was the Thomas Pipe Inn) built in 1853 is of the Greek Revival style and balloon frame structure. Both

BURNING PERMITS

With the snow finally melting it is time to remember to obtain free burning permits from your DNR Fire Wardens. Permits are required anytime the ground is not snow covered during the months of January, February, March, April and May. Permits are needed for everything except cooking or warming fires. The safe time to burn is from 6 p.m. to midnight. You are responsible for all suppression costs incurred from a wildfire caused by your negligence! Wet rubbish, oily substances, asphalt, plastics of any kind and rubber products are prohibited to be burned by law.

Plastics: Check for a neck! The only plastics accepted must have a neck and be a #1 or #2.

Landfill/Recycling Site: Current site to remain open until May 31, 2007. The new Transfer Facility will be located west of the Materials Recovery Facility (MRF) off County B & Apache in Plover. It will open when the landfill closes.

Compost Bin & Pail Sale: May 12, Saturday 9 am to 2 pm at the MRF and May 19, Saturday

8-11 am at the Master Gardener Plant Sale. The bins are \$43 and the Kitchen Katcher Pails are \$18..

Continuous Clean Sweep Program: Hazardous materials may be brought in to the Landfill at Custer M-F 7:30 am to 3:30 pm from March 12 through May 31 and to the Transfer Facility after that date. A small fee is charged. Businesses and farmers must pre-register by phone..

Fluorescent Lamp & Computer Recycling Day: May 2, Wednesday, 9 am to 2:30 pm at the County Highway Facility. If unable to attend the event, these items are also accepted for recycling at the Landfill Site during regular hours M-F 7:30 am to 3:30 pm and Saturday 8 am to noon.
