Board members Mike Pagel, Bill McKee and Elmer Garms were present as well as the Clerk, Cheryl Leatherman, Deputy Clerk Kim Beaudoin, and two residents.

A **Public Hearing** was held at the Town Hall on Thursday, November 16, 2023 at 7:00 p.m. The hearing was called to order by Chairperson M. Pagel at 7:00 p.m. The 2024 Proposed Budget was distributed and reviewed. Motion to close the Hearing by M. Pagel, seconded by M. Sannes and carried by voice vote at 7:12 p.m. (7 in favor, none opposed)

A **Special Town Meeting** followed. The Meeting was called to order at 7:13 p.m. by M. Pagel. Motion by M. Pagel to adopt the Town Tax Levy for 2023 payable 2024 of \$288,771 (\$1.437 per thousand valuation), seconded by P. Rock and carried by voice vote at 7:13 p.m. (7 in favor, none opposed). Motion to close the Town Meeting by B. McKee seconded by E. Garms and carried by voice vote at 7:14 p.m. (7 in favor, none opposed)

The **Special Town Board Meeting** followed. The Meeting was called to order at 7:14 p.m. by Chairperson M. Pagel.

1. Motion by E. Garms to adopt the 2024 Town Budget of \$694,932.17, seconded by B. McKee and carried 3-0-0.
2. The Board discussed the request by JR Hutch Memorial Trust c/o Steve Rohleder, 531 Dean Street, Woodstock, IL 60098 to split parcel .098 acres from parcel 022-22-1010-08.03, 4.57 acres zoned Conservancy, RL, and A3 and upon sale combine it with parcel 022-22-1010-A, 4.28 acres zoned Conservancy and A3 at the request by Tomorrow River LLC, 6716 Millcreek Road, Shawnee, KS 66217. Since the request was received, Tomorrow River LLC has notified the Town that they are not interested in completing this property transaction at this time, therefore no action was taken.
3. The Board discussed the refuse charge for 2023 payable 2024. Motion by M. Pagel seconded by B. McKee and carried 3-0-0 to set the refuse charge for 2023 payable 2024 at \$210.03.
4. The Board discussed the fire number sign charge for 2023 payable 2024. Motion by B. McKee seconded by E. Garms and carried 3-0-0 to set the fire number sign charge for 2023 payable 2024 at \$59.22.

5. Motion to adjourn by M. Pagel seconded by E. Garms and carried 3-0-0 at 7:34 p.m.
